## **Update on Action Items:**

- 2. Chad will email the board the association liability policy once he receives it back from the attorney with the changes. Not received from the attorney.
- 3. Jarid will update the dues section in the By-Laws for the dues increase for 2025 and record with the county. This is not done.
- 4. Jarid will follow up with Brady Anderson and have him sign the easement agreement. This is done and Jarid will add it to google docs.
- 5. The replacement key policy will be added to the website under the key and remote policy. Jarid

### **New Items:**

 2024 Year End Budget Review. The board reviewed the budget, there is \$8000 left over from the SCR road budget. Russel said culverts are going to be going up next year. Jarid recommended we spend \$7000 on culverts. Russel made a motion for culverts, Mike second the motion. The board approved culverts. We will order 18" and 15" culverts. Mike will put a proposal together and get it confirmed. Russel has offered to store the culverts at his shop. The address is 1355 S Blackhawk in Mt Pleasant. Mike will coordinate with Russel for delivery of the culverts.

- 2025 Budget Estimate. Jarid will make a few updates to the budget. He will send it to the board.
- 3. Check in on Gates.
  - a. How are they doing and do we need to do anything to prepare for winter? Gate 3 needs to be welded over the cover. There is some extra chain on gate 7.Scott is taking the cylinders to Ron Nay. He will ask him if he would be willing to take care of this. Mike suggested we pay Ron.
- 4. Final Road Maintenance Review for the year. We got Doug fully paid for the year. Rick Allred has been paid.
- 5. Road Plowing Tracy is working with the contractor who plowed the road. They salted the road and put rejected sand on the road. Jared said all would be cleaned up. Jared will get down there in the next week or two and follow up on the roads.
- 6. Meadow Road Follow Up Discussion with WP3 Chad
- Parking Permits discussion regarding the seasonal parking permits. In order for everyone who wants
  to park in the parking lot during the winter season, we will continue to issue 1 parking permit per
  owner(s).
